

**UNIVERSITY OF KYRENIA**  
**UNIFORM REGULATIONS FOR MARITIME PROGRAMS**

**Aim:**

The aim is to determine the principles of appearance and uniform standards to help students gain ability of complying with the rules, developing discipline and acquiring a sense of belonging, which constitutes an important part of the very special Maritime Education.

**Content:**

These regulations apply to all of the maritime programs - the **Faculty of Maritime Studies, Faculty of Maritime Management and Administration, Maritime Academy, Maritime Vocational School** - students studying under all these programs of the University of Kyrenia. These regulations also apply to the relevant students studying the English Foundation Program.

**Duration and Application**

Students are obliged to wear uniforms within the period from the beginning to the end of the school years. The uniform must be worn during the entire course period including the exam week and practical or laboratory hours. Students without uniforms will not be allowed to attend the classes, exams or practical trainings. The maritime administration and the captain of the ship have the authority and responsibility of ensuring that students wear the uniform during the internship period as well.

Winter uniform (navy blue) will be worn between 2nd of November and 30th of April, summer uniform (white) will be worn between the 2nd of May and 31st of October. For practical trainings taking place on ship, the khaki coloured uniform can be worn. Hats must be worn indoors and outdoors within the university premises.

**General Behaviour**

The general behaviour of the students completes the importance of the uniform. The male students of the maritime programs must have a hair cut in such a way that it does not overflow their hat. They cannot have long hair and cannot leave a beard. Male students must shave faces every day.

Female students can have either short hair or long hair which is tied up. They must not exaggerate with their make up and should not use jewelry.

Students in uniform must behave appropriately in accordance with these requirements. They must not indulge in bad behaviour or take part in activities such as mass demonstrations or boycotts organized by other students.

## **Uniforms:**

Uniforms should be in accordance with the Turkish Maritime Tradition, which is given below;

## **Authority and Responsibilities;**

The Dean of the **Faculty of Maritime Studies**, the Dean of the **Faculty of Maritime Management and Administration**, the Director of the **Maritime Academy**, the Director of the **Maritime Vocational School** are responsible for the implementation of these uniform regulations. Students who do not comply with the regulatory requirements or who deliberately do not follow the regulations will be penalised with the authority of the deans or directors.
